The Learning for Life National Service Center is pleased to share with you the 2025-2026 Intellectual Property License Agreement for the Learning for Life Curriculum-Based program. Please remember that the Intellectual Property License Agreement does NOT apply to Exploring.

The Learning for Life program includes access to Pre-K through High School and Special Needs character education curriculum teacher guides.

Please submit the signed Intellectual Property License Agreement as soon as possible to the Learning for Life National Service Center (susan.fitzhugh@scouting.org), no later than September 30, 2025. If your council chooses not to renew the Intellectual Property License Agreement, please sign and check the box in the area where it says, *Council will NOT renew*.

If you have a special circumstance that may require extra time to return this agreement, please let us know, and we will work with you.

Please notice that your signed license agreement will be valid from (August 1, 2025, through September 30, 2026. The lump sum ACH payment must be made within the fiscal year 2026 (between the dates of January 1, 2026, through January 31, 2026). Champions “Special Needs”, Pre-K, Kindergarten, 1st Grade, 2nd Grade, 3rd Grade, 4th Grade, 5th Grade, 6th Grade, 7th Grade, and 8th Grade books are now available.

We anticipate the High School Curriculum Book that covers grades 9th-12th to be released by the end of September 2025.

We will now provide PDF versions of the newly updated books to you at no additional charge, and you may also print the books locally at a printer of your choice.

In addition, we have secured a vendor for a “print on demand option” when you have the need for printed books. The cost will vary, depending on the book, and you can contact Susan Fitzhugh susan.fitzhugh@scouting.org to help you with pricing options.
