The Learning for Life Curriculum-Based program includes access to Pre-K through High School and Special Needs character education curriculum. The PDF versions of these books are now available at no cost to you with a current License Agreement.

***Please remember that the Intellectual Property License Agreement does NOT apply to Exploring or to the new test pilot for the LFL Community Impact Program.**

Please submit your signed Agreement as soon as possible to the Learning for Life National Service Center at **susan.fitzhugh@scouting.org**, no later than **September 30, 2026**. If your council chooses not to renew, please sign and check the appropriate box. If you need additional time, please let us know.

Your signed license agreement will be valid from **August 1, 2026, through September 30, 2027**.

The lump sum ACH payment must be completed within fiscal year 2027 (**January 1 – January 31, 2027**).

5	Up to 7,500	\$26,250	+\$3.50 per student over 7,500
